### **Payment Policy:**

Registration is not complete until full payment has been received or first payment of electronic funds transfer (eft), monthly plans are received. Payments not received before the golf sessions begin will result in no admittance of the person(s) to the golf session. Payment may be made by Check, Visa, MasterCard or Discover card with the submission of a completed registration form. A processing fee of \$25 will be charged for returned checks and the registration will be canceled automatically until a valid form of payment is received.

### **Refund Policy:**

Cancellations occurring more than 48 hours prior the start of the event will be refunded 100%. Events are considered any private or group program that was registered for by the student.

Cancellations occurring within 48 to 24 hours of the event will incur a cancellation fee of \$25. Cancellations occurring within 24 hours of the event can only be made by calling or texting the instructor involved for that event.
